Legislation Update: Always Hire a Licensed Contractor

Property owners should always hire a licensed landscape contractor when contracting out for the installation of a landscape, especially water-efficient landscapes. Licensed landscape contractors are also allowed by law to design the landscapes they build. The Contractors State License Board (CSLB) tests, licenses, and regulates landscape contractors to protect consumers. All contractor members of CLCA are licensed, although consumers should still check license status on the <u>CSLB website</u> before hiring any contractor. To find CLCA-member contractors who work in any particular area of the state, go to the <u>Contractor Search</u> page of the CLCA website.

The CLCA SLO chapter is looking forward to making a difference on the Central Coast – if anyone is interested in joining a task force to discuss opportunities for unlicensed contractors to become licensed, please send an email to our board members, who's contact info is on the previous page.
